Shoppers who attend the popular Rancho Solano Holiday Boutique (held the Sunday before Thanksgiving) look forward to the spring edition of the show! We are pleased to host it this year on Sunday, March 29. The timing is perfect for Easter and Passover, Mother's Day, graduations, weddings, and items for home and garden, etc.

The Clubhouse at Rancho Solano Golf Course is a 7200 square foot banquet facility overlooking the golf course and the Napa hills. It is an elegant display space for your hand-crafted items.

If you've participated in our events you know we do a lot of advertising:

- 6,000 marketing postcards will be distributed locally and around northern CA
- Radio spots on KUIC 95.3 reaching Solano, Contra Costa, Napa and Yolo counties
- Colorful post-it on front page of the local newspaper; 100 green and yellow "yard" signs
- ½ page ads in the local Your Town Monthly magazine mailed to total 75,000 homes in Fairfield, Vacaville, and surrounding areas
- Paid Postings on Internet events sites, community calendars, social media and more.....

Here are the details:

- There are around 80 indoor vendor spaces, mostly 8 foot tables or 5x5 spaces and a handful of outdoor spaces for garden art.
- Tables, white tablecloths, and chairs are provided.
- Electricity is provided to 8 foot tables. Not available for 5 foot round spaces. Please indicate "electricity" in requests if needed and bring a heavy duty cord to connect.
- *Artists and Artisans* \$145 (+\$15 late fee after March 1)
- Limited number of pre-packaged *Food Vendors* \$165 (+\$15 late fee after March 1)
- **Categories will close as they fill up, so please send registration early. Returning vendors have priority**
- **Jewelry is by far the most popular category and there is a waiting list for new jewelry vendors.**
- **Returning vendors. Please request your same space by Feb. 1<sup>st</sup>. First come, first served after Feb. 1<sup>st</sup>.**
- **To reserve your space, please return the registration form with your check NOW. If needed, you can post-date the check to March 1, 2020 and it will be deposited on March 1<sup>st</sup>.**
- If your application is not accepted, you will be notified and your check returned.
- Vendors are required to have a seller's permit (also known as resale permit) issued by the CA Dept. of Tax and Fee Administration: <http://www.cdtfa.ca.gov/services/permits-licenses.htm>
- You are responsible for collecting CA sales tax.
- Cancellations are accepted in writing and must be received by March 15, 2020. A \$25 handling fee will be deducted from the refund. No refund for inclement weather.
- **FOOD VENDORS must file the required special event permit with Solano County Health Dept. Please call Solano County Dept. of Resource Management, (707) 784-6765 for questions or clarification of Health Dept. rules or permits.**
