After a 2-year hiatus, the business members of the Suisun City Historic Waterfront District are delighted to invite you to participate in the Mother's Day Artisan Fair! The annual Mother's Day Artisan Fair is a fun family tradition started in 2010! We're very excited to bring it back to the community at large. The event includes:

- 70+ handcrafted artist, artisan and food booths
- LIVE music! 2 live bands!
- Champagne and Mimosa or similar served in commemorative glass.

The Artisan Fair is held at Harbor Plaza (Main St & Solano St), Suisun City. The park sits beautifully overlooking the waterfront with pathways through grassy areas and is in close proximity to a number of fine restaurants. Mother's Day is a busy day with families treating Mom to a meal out and enjoying the park and waterfront. It is a beautiful setting for your hand-crafted items and a perfect day for the show!

Here are the details:

- All local and state COVID rules/regulations are followed.
- Cost is \$125 for 10' X 10 artist or artisan space. Food vendor space is \$160 for pre-packaged and \$250 for "eat-there" foods. **Please make same space requests ASAP. FIRST COME, FIRST SERVED after April 1.**
- Please send application and check now, but **date your check April 8, 2022.** All checks will be deposited on April 8, 2022. If your category is full, we will let you know and you will be put on a wait list.
- Vendors provide their canopy, tables, tablecloths, chairs, etc. The event is held rain or shine. No refund for inclement weather.
- **Electricity is NOT available.**
- Vendors are required to have a CA seller's permit issued by the CA Dept. of Tax and Fee Administration: <https://www.cdtfa.ca.gov/taxes-and-fees/fagseller.htm>
- Vendors are responsible for collecting CA sales tax. Suisun City 2022 sales tax = 8.375%
- Cancellations are accepted in writing and must be received by April 27, 2022. A \$25 handling fee will be deducted from the refund.
- **FOOD VENDORS must file the required special event permit with Solano County Health Dept. Please call Solano County Dept. of Resource Management, (707) 784-6765 for questions or clarification of Health Dept. rules or permits.** LINK: [2022 Required Health Dept. Permit Application](#)
