The Clubhouse at Rancho Solano is a 7200 square foot banquet facility overlooking Rancho Solano Golf Course. It is a beautiful spot and elegant display space for your hand-crafted items. The Clubhouse and the can accommodate 75-80 vendor spaces (including a few outdoor spaces under the entrance portico). The show has a waiting list every year.

This is my 15th year coordinating the boutique (except pandemic year). The level of artisans has made the show a huge success! Shoppers flock to the boutique because of the range and quality of the items presented! The show has a great reputation among artists and artisans too and we appreciate the referrals from vendors who recommend the show to new artisans. No commercial items.

The Sunday before Thanksgiving is "THE" boutique day so shoppers are looking for us then. We put up 100 "yard signs" to lead shoppers to us. We are hard to miss!

~ tables, chairs and white tablecloths are provided and you can decorate your table any way you choose. Electricity is available to most 8-foot tables. Please bring a heavy-duty cord if you request electricity

~ Cost for an 8-foot table, 5-foot round table or 6'x6' foot space to use your own shelves or racks is \$145. After Oct 1st a \$15 late fee.

~ There will be limited spaces for pre-packaged food vendors. Cost is \$165 for food vendors. Link to the required One Day Health Dept. permit is attached.

Please let us know NOW if you plan to sign up... and mail your application to secure your space...thanks! If you are on the Wait List or if your application is not accepted, we will contact you. No commercial items.

There is always a wait list, so please sign up early.

- Returning 2022 artisans; To assure your SAME SPACE, please sign up by August 1st.
- AFTER August 1st SPACES WILL BE FILLED FIRST COME-FIRST SERVED.
- Categories close as they are filled. You will be notified if on the waiting list.

Please date your check Oct 1 and it will be deposited on Oct 1. Venmo and Paypal also accepted.

There are a limited number of vendors in each category.

Please note: Jewellery and soaps/lotions/spa products categories.....If you are NEW to the show or did not participate in 2021, you will be added to a waiting list.. Unfortunately, these categories are often filled with returning vendors from the previous year.
